Two Directors (one for 3 years and one for 2 years OR one for 2 years and one for 1 year) (Best to have elections in alternate years)

One Director will be Executive Board Director(to be voted on every year)

Executive Board meets once a month. They make a lot of decisions and bring those to the board (they are like a committee).

Directors can be officers. It is hoped that all district representatives should at least come to the annual meeting. It is planned to have a one-day meeting in the middle of the state to see what the districts need.
